Please let this serve as an official notice that the intent to enter into an "Interlocal" with Delta Lake Irrigation District for the purposes of irrigating approximately 30 acres of Delta Lake Park grounds was not successful.

In sending the revised Interlocal to Delta Lake Irrigation District's General Manager for his review as to form of document for possible consideration resulted with the conclusion that due to their current water situation the district is facing themselves with, the district will not be able to enter into this agreement. They would only be able to serve its current customers.

I was previously advised of this possibility back on Friday, June 1, 2012, while in correspondence with Ms. Perez while I was working with legal on the revisions to the document. Nonetheless, my purpose was to have them review the revised document for possible consideration, however, it did not result in that.

Therefore, I will be placing an agenda item to rescind action previously taken back on January 24, 2012 of the request to enter into an agreement with the district.
