ARRATIVE:

- Reporting Party; Ruben Lopez (10.28-44) who said:
- He works for PCT 2
 - Yesterday he left the collection site at about 4:30 p.m.
 - He made sure everything was secure
 - Today he came back and noticed the security system was missing (2 cameras, monitor, and wire)
 - He noticed the burglar bars on the window had been pulled off
 - The monitor was missing from the building
 - He did not give anyone permission to enter the building or to take the property
 - He does not know who took the property
- He wants to file charges

Actions/Observations

- Arrived at location
- Obtained information
- Observed damage to the building
- Dusted for latent fingerprints; was able to collect one card
- Provided a business card and case number
- Observed foot prints leading west behind the site
- Checked the surrounding area for the property, but to no avail
- No further action taken / Resumed Patrol
