Javier Hinojosa Engineering has reviewed bids and tabulations and is recommending Jimmy Closner and Sons Construction Company, Inc. of _____TX as the low bidder for the above-referenced project. The County was awarded \$423,757.12 for Road Work and \$114,490.00 for Drainage for a total of \$538,247.12. Based on the apparent low bidder, the County will have an underrun of \$34,549.75 for Road Work and \$5,763.50 for Drainage.

The award will be to the low bidder Jimmy Closner and Sons Construction Company, Inc. with a low bid amount of \$392,013.75.
