Hidalgo County WIC Baby Café is a drop-in center offering free breastfeeding help, information and support in a relaxed environment. Hidalgo County WIC Baby Café is part of the Baby Café Charitable Trust out of the U.K. (www.thebabycafe.org). We welcome all pregnant women, breastfeeding moms and their supporters to our friendly drop-in center.

Mothers and potential mothers will receive:

- Information about pregnancy
- Information about breastfeeding
- Support with common breastfeeding problems
- Advice on returning to work while still breastfeeding
- Information on re-lactation and weaning
- Information about other agencies

A relaxing non-clinical, café-style environment is the setting that will be provided. Decaff coffee, tea and a healthy snack will be available. A child friendly play area is also available for accompanying children.

We would like to provide March of Dimes health education materials for every woman and their supporter that attends along with incentive items such as baby hygiene items and diapers. This would act as an incentive to get the word out to other moms so that they will visit Baby Café too.

Hidalgo County WIC Baby Café is located behind the North San Juan Resource Center 509 E. Earling (Nolana) Road. Our hours of operation are Mondays and Wednesdays from 2:00 p.m. to 4:00 p.m. Also, the 1st and 3rd Saturdays from 9:00 am to 12:00 pm. Approximately opens 20 hours a month. The facility is staffed by a Lactation Consultant and a Peer counselor at all times to help moms.
