If that is not correct, please remove that statement. Otherwise, all other revisions are highlighted. Also, item number 3 on page 2 "Payment for Services" indicates that TALHO will pay for services on behalf of County. Do we have an agreement in place for that? If so, you should include it as part of your back up. The Auditor will definitely question this provision.
