Hi Chris!

I was a bit confused by this email and the contract dates mentioned, so I've done a little research and this is what I found out.

1. Your original agreement to purchase BADGE was initiated in April 2010.
2. Cardinal did not complete the installation and training or issue an invoice until 9/14/2010. The original software license & support agreement that came with your purchase officially began 10/1/2010 and expired 9/30/2011. (see attached invoice #94824.
3. You renewed your contract in August of 2011, Invoice #97376 (see attached). New contract dates: 10/1/2011-9/30/2012.
4. You renewed your contract again in August of 2012, Invoice #100408 (see attached). New contract dates: 10/1/2012 - 9/30/2013.

Based on my research, your current expiration date is 9/30/2013 and therefore a 60 day extension for the period of April 27, 2013 - June 25, 2013 is not necessary. You won't receive a new renewal invoice until July of 2013 for the next contract dates of 10/1/2013 - 09/30/2014.

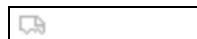
