Thank you for the response. From a quick search on our system, it appears that the Hidalgo County Health Department is an enrolled Medicaid provider. We should be able to provide the DY1 DSRIP payment to Hidalgo County without the county needing to sign the Interlocal Agreement. However, for audit purposes, could you please provide a letter signed by the appropriate county authority stating your direction to HHSC to deposit the DY1 DSRIP payment as it would any other Medicaid payment to your health department? Within the letter, please provide the name of official name of the health department and the relevant Medicaid provider number.
