Good morning Josie, Commissioner Tito needs an ICA with the city of Pharr for the Thomas Road project. This project will make the road a thoroughfare within Hidalgo County. The County is spearheading the project using Federal and local funding. The precinct has an Advance Funding Agreement with TXDOT for this purpose. The ICA is needed for two purposes: 1) to notify the City of Pharr of the upcoming road construction and engineering and 2) notify City of Pharr that after a year of construction completion the City will be responsible for the maintenance of the road.

Forthwith is some language that may be used in the ICA.

County at its sole cost and expense shall provide all engineering services necessary or required for the reconstruction of the Road and County shall be the lead for the reconstruction of the Road


The County agrees it is in its best interest to reconstruct road as such Road serves as a connecting link and integral part of the County road system

Pharr pursuant to Texas Transportation Code 251.012 authorizes County to perform the work and services described herein within its corporate city limits.
