I have attached the Bid Tabulation and the Cost Breakdown on the bids recently opened for the Trenton Terrace project. Base on the cost breakdown, the cost of roadwork is approximately 64% (\$134,022.68) over the amount awarded for roadwork. The drainage cost of the project is within the awarded amount.

The cost of roadwork has increase due to increase in materials for roadwork. Material cost has increase approximately 25%. Please let me know what direction I should with this project.
