

RESOLUTION

WHEREAS, within the parameters set by Chapter 76 of the Government Code, the Hidalgo County Board of Judges agrees it is in the best interest of the citizens of Hidalgo County, that the Hidalgo County Adult Probation & Sheriff's Office Initiative be operated by the Hidalgo County CSCD for the 2012 -2013 biennium ; and

WHEREAS, within the parameters set by Chapter 76 of the Government Code, the Hidalgo County Board of Judges agrees to approve applicable matching funds for the said project as required by the Hidalgo County Adult Probation & Sheriff's Office Initiative grant application; and

WHEREAS, within the parameters set by Chapter 76 of the Government Code, the Hidalgo County Board of Judges agrees that in the event of loss or misuse of the Criminal Justice Division funds, the Hidalgo County Board of judges will instruct the department director that the funds be returned to the Criminal Justice Division in full.

WHEREAS, within the parameters set by Chapter 76 of the Government Code, the Hidalgo County Board of Judges acknowledges the Hidalgo County CSCD Department Assistant Director as the grantee's authorized official. The authorized official is given the power to apply for, accept, reject, alter or terminate the grant on behalf of the applicant agency.

NOW THEREFORE, BE IT RESOLVED that within the parameters set by Chapter 76 of the Government Code, the Hidalgo County Board of Judges is of the opinion that the submission of the grant application for the Hidalgo County Adult Probation & Sheriff's Office Initiative to the Office of the Governor, Criminal Justice Division by the Hidalgo County CSCD is in the best interest of the citizens of Hidalgo County.
