**AMENDMENT TO SERVICE CONTRACT
C-2010-002-09-28**

This **AMENDMENT** to the **CONTRACT** for **PATHOLOGIST TO PROVIDE TURKEY AUTOPSY AND RELATED SERVICES** dated September 28, 2010, by and between **HIDALGO COUNTY, TEXAS** (“County”) and **NORMA JEAN FARLEY, M.D.** (“Contractor”) is entered into and agreed between both parties effective this **17th Day of September, 2013**.

WHEREAS, Contractor and County entered into a Contract dated September 28, 2010 in which contractor agreed to provide certain services for the purpose of “Pathologist To Provide Turnkey Autopsy And Related Services” for Hidalgo County (the “County”);

WHEREAS, the commencement date of the Contract is hereby as of September 28, 2010 and the Contractor and County now desire to amend the Service Contract to include the following as stated;

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Contractor hereby agree to the following amendment to the Contract:

1. **SECTION 14 TERMINATION OF AGREEMENT** has been amended as follows:

14.2 Renewal Option: County and Contractor agree under the renewal option of the Contract to continue services on a month to month basis not to exceed six months.

Except as modified herein, all terms and conditions of the original Contract, as amended, remain in full force and effect and County and Contractor ratify and confirm the terms and provisions of the Contract as amended.


