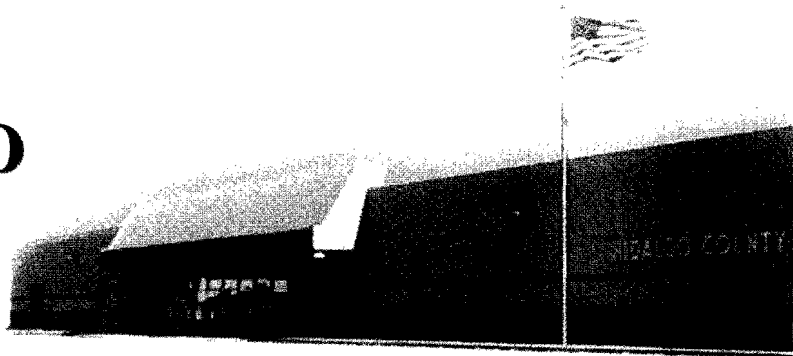

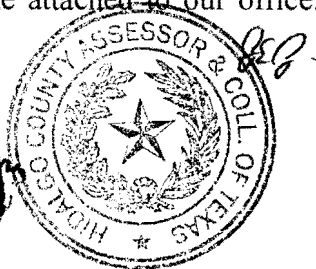
Gentlemen:

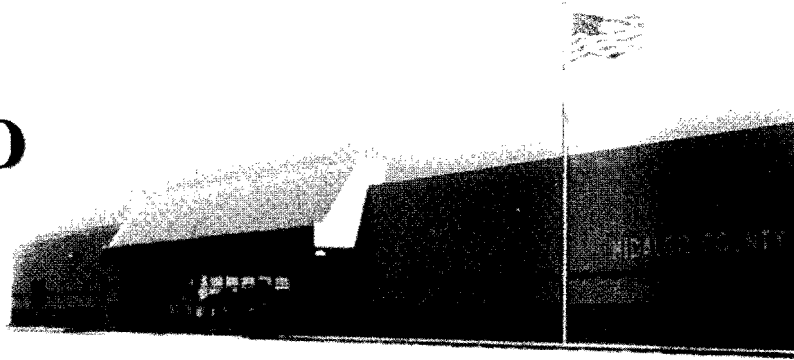
