Michael,

Good Afternoon. I'm assisting the Sheriff's Office with an Amendment to the Rio Grande Valley Communication Group Interlocal for Commissioners Court approval. I have attached the Interlocal passed on 11/18/2011 as well as the Amendment passed by the RGVCG on September 18, 2013. Hidalgo County is requesting to amend the amount of radios on the system from 100 to 2500 as described in Section II below. Please review the Amendment and let me know if you approve to form. If you have any questions, please call me.

II. DUTIES OF RGVCG

A. In General

During the Contract Term, RGVCG shall provide radio air time on and support for the Regional Radio System (RRS) for as many as **100** Radio Units. The numbers of units for either primary or back-up dispatch on the Radio System may be increased by mutual written agreement of the RGVCG and Hidalgo County.

Within 30 days of Countersignature, the RGVCG shall program the radio unit(s) according to the initial configuration agreeable to the RGVCG Communications Manager and Hidalgo County. RGVCG may program each radio unit, for a service charge, with the capability to access the Radio System within 30 days after submittal of such Unit to the RGVCG Radio Support Section for programming.
