RE: "Sole Source Declaration" - Smith Detection Inc.

As part of the duty/obligations to protect the residents of Hidalgo County as well as secure property, the Hidalgo County Sheriff's Office requires the acquisition of inspection, certification of equipment and maintenance and repair services for the X-ray security machine located at the Hidalgo County Courthouse for state compliance purposes.

Smith Detection is the "sole manufacturer" and provider of services (i.e. inspections, certifications, replacement parts, repair & maintain services).

Therefore Hidalgo County must acquire parts and services for the X-ray security equipment thru Smith Detection Inc.
