- \* *The Applicant agrees to comply with and be bound by the provisions of the Articles of Incorporation and Bylaws of the Cooperative, and such rules and regulations as may from time to time be adopted by the Board of Directors of the Cooperative.*
- \* *The Applicant agrees to pay for all electric energy used in accordance with and subject to the limitations set out in the Cooperative's applicable rate schedule.*
- \* *It is also agreed that membership in the Cooperative shall begin when service is connected and shall be terminated when Applicant's service is disconnected and Applicant is no longer receiving electric service.*
- \* *In the event this membership is terminated, and subsequent thereto the applicant should desire to again become a member, this application for membership will be applicable for any and all future requests for membership. However, each request for membership must be subject to approval by the Board of Directors of the Cooperative.*
