**WHEREAS, Section 504 of the Rehabilitation Act of 1973 requires accessibility for persons with disabilities and prohibits discrimination based on physical handicap; and**

**WHEREAS, Executive Order 11246 Equal Employment Opportunity provides that there shall be no discrimination in employment under federally assisted construction activities; and**

**WHEREAS, the U.S. Department of Housing and Urban Development continues to enforce the Fair Housing Act, to ensure all Americans have the right to access housing regardless of race, color, sex, religion, national origin, family status or disability; and,**

**WHEREAS, as predetermined by the Secretary of Labor in accordance with the Davis-Bacon Act to all laborers and mechanics employed in the development of any part of the housing and contracts involving their employment shall be subject to the applicable provisions of the Contract Work Hours and Safety Standards Act**

**NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED BY THE COMMISSIONER'S COURT OF THE COUNTY OF HIDALGO, TEXAS:**
