
Dear Judge and Commissioners:

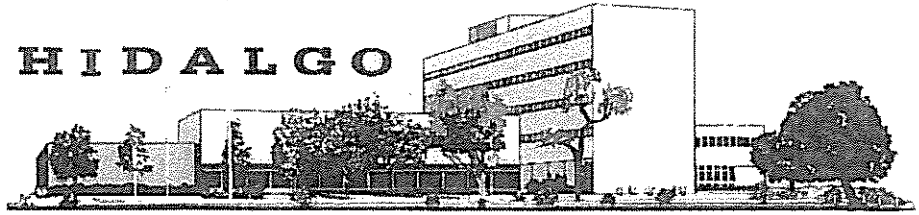


