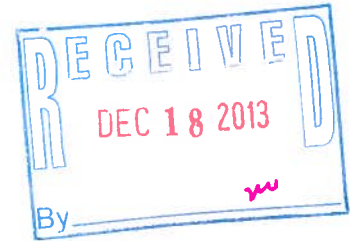

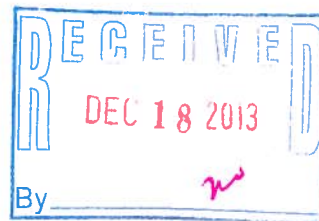

Comments:

- SAR can/does provide 53' dry van trailers for the temporary storage and ~~transport of waste tires~~
- SAR does not provide nor transport roll-off containers
- SAR does accept waste tires delivered to the facility by the customer
- All tires are documented by weight this includes tires delivered to SAR facility by customer and tires transported by SAR in SAR trailers to the waste tire facility
- Tires are not counted a PTE (Passenger Tire Equivalency) is provided at the customer request.
- TCEQ rules state that a standard passenger tire weighs an average of 22.5 LBS.
- PTE is derived by taking the combined weight of the tires per load and dividing it by 22.5
- Example a load of tires weighing 25,000 LBS has a PTE of 1,111 tires
- SAR provides one manifest and one invoice for every load of tires either delivered or SAR transported
- TCEQ rules state that a maximum of 500 waste tires can be stored on the ground at any given time without a storage permit and up to 2000 in an enclosed lockable container in the event that the customer elects to utilize SAR's 53' trailers for the storage and transport of waste tires there are two (2) options available in order to remain in compliance:
 - A: The customer may have county employees load the tires directly into the trailer(s) as they arrive at county facilities \$1,300.00/trailer**
 - B: SAR can provide SAR employees to load the tires on a bi-weekly basis, Tuesdays and Thursdays \$1,700.00/trailer**
