Narrative: Officer A. Garza #36

On November 13, 2013 at 1545 hours I, Patrol Officer Adrian Garza #36 was dispatched to 1051 North Doolittle Road (Hidalgo County Precinct 4) in reference to a theft.

Upon arrival contact was made with Regino Salinas Jr. (supervisor) who reported that he wanted a theft report filed due to an unknown actor (s) taking a red Lincoln welder 5500 watt generator from the mentioned facility "without consent". Mr. Salinas went on to report that he last saw the generator back on August 1, 2013. Mr. Salinas informed me that he wants the report on file for inventory purposes and does not wish to file charges at the current time. At this time I asked Mr. Salinas if he knows the value of the mentioned generator and he stated \$900.00 dollars. I then told Mr. Salinas that the generator would be entered stolen into our database informed him that a report would be made and provided him with a case number.

Note: Attached to report is the stolen entry entered by dispatch. Also Mr. Salinas does not know where exactly the generator was located when it was taken from the shop.
