The proposed amendment will delete the current streets: Baker Drive (from FM 1015 to Catarina Street) 2) Baker Drive (from Arroyo Street to Gonzalez Road), and Miracle Road (from Catarina Road to end of road going west); and add the following streets: Champion St. (from Business FM 1015 to Miles Street), East Palms St. (From Miles St. East to Dead End.), West Palms St. (from Lyons St. West to Dead End), Colonia La Leona M Flores St. (from Business FM 1015 east to dead end), Hidalgo St (from Shelby St, North to Malone St.), previously environmentally cleared in FY 25 (2012).






