

FALSE ALARMS, FALSE ALARM LIMITATIONS, and FALSE RESPONSE FEES.** False alarms responded to by the Police Department shall be limited to three (3) per calendar month, per alarm module or Department notification by an alarm company. False alarms in excess of 3 per calendar month will require the payment by the alarm company (permittee) to the Police department on the following schedule:

4TH FALSE ALARM - \$50.00
5TH FALSE ALARM - \$75.00
6TH FALSE ALARM - \$100.00
