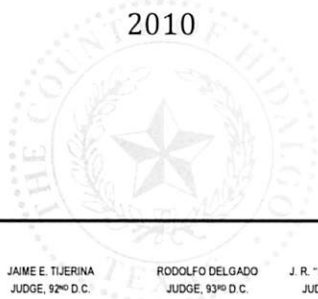

**Re: Forfeitures of Gambling Proceeds**

Dear Mr. Guerra:

This letter is to notify you of funds reserved in the General Fund that represent seizures of gambling proceeds, criminal instruments and other contraband. These funds have been reserved because their use is restricted to the grand jury program of the County under Article 18.18 of the Texas Code of Criminal Procedure. The total amount reserved as of December 31, 2013 is \$140,093.19 as follows:



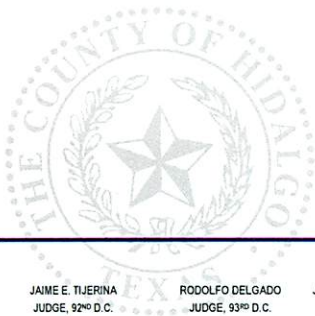
