RECEIPT AGREEMENT UNSUCCESSFUL OR UNACCEPTABLE HIDALGO COUNTY SHERIFF'S OFFICE K9 DOG

In consideration of the Hidalgo County Sheriff's Office, rejection of "K9-Bombix", Asset #49599, and subsequent transfer of ownership to **Eduardo Javier Rivera**, named donee, receipt is acknowledged, and which I know to be a dog which was found to be unacceptable for type training required or rejected due to medical deficiency, and insufficient drive, I hereby agree and warrant as follows:

1. Upon signing of this form by me and by The Hidalgo County Sheriff's Office's authorized representative, The County of Hidalgo relinquishes all right, title and interest in said dog, and all responsibility for its condition and actions, and accepts and assumes full ownership of said dog and complete responsibility for its condition and actions.
2. Therefore, I will indemnify and hold harmless the County of Hidalgo and The Hidalgo County Sheriff's Office and its agents and employees against and from any and all claims which I, my heirs, executors, or assigns may now or at any time in the future have arising from any cause or in any manner connected with the condition or conduct of said dog.
3. I further state that I have not exchanged money or anything else of value except my agreement made herein for the said dog.
4. Further, I accept this dog fully aware that the County of Hidalgo and the Hidalgo County Sheriff's Office makes no warrant or guarantee of its condition of health or temperament, or its future behavior.
5. Considering the above, I understand that the County of Hidalgo assumes no liability for damages to the property of the donee, **Eduardo Javier Rivera**, or for personal injuries, disabilities or death of the donee or the donee's employees or to any other person arising from or incident to the donation of this animal or its use or disposition. The donee shall hold the County of Hidalgo and the Hidalgo County Sheriff's Office harmless from any and all such demands, suits, actions, or claims of whatsoever nature arising from or out of the donation of this animal.

RESOLUTION

WHEREAS, The Hidalgo County Commissioners' Court finds that Hidalgo County Sheriff's Office **K9 "Bombix"** a male Belgian Malinois, **Asset #49599**, is found to be unacceptable for any type of police work due to its medical deficiency and continuous medical expenses due to early onset kidney failure. The court finds it in the best interest of the citizens of Hidalgo County that **K9 "Bombix"** be relieved of his police duties with The Hidalgo County Sheriff's Office and donated to a reliable person, therein named Hidalgo County Sheriff's Sergeant/ Deputy **Eduardo Javier Rivera**, to care and maintain it for the remainder of **K9 "Bombix's"** life span.

WHEREAS, Hidalgo County Commissioners' Court agrees to relinquish all rights, title and interest in said **K9 "Bombix"** and all responsibility for its condition and actions, and that therein named **Eduardo Javier Rivera** accepts and assumes full ownership of said dog and complete responsibility for its condition and actions. **Eduardo Javier Rivera** will also hold harmless the County of Hidalgo and The Hidalgo County Sheriff's Office and its agents and employees against any and all claims which **Eduardo Javier Rivera's** heirs or executors now or at any time in the future have arising from any cause or in any manner connected with the condition or conduct of said dog. The court recognizes that **Eduardo Javier Rivera** did not exchange money or anything else of value except his agreement made herein for the said dog.

WHEREAS, Hidalgo County Commissioners' Court understands that The County of Hidalgo assumes no liability for damages to the property of **Eduardo Javier Rivera**, or for personal injuries, disabilities or death of **Eduardo Javier Rivera** or to any other person arising from or incident to the donation of this animal or its use or disposition. **Eduardo Javier Rivera** shall hold the County of Hidalgo and the Hidalgo County Sheriff's Office harmless from any and all such demands, suits, actions, or claims of whatsoever nature arising from or out of the donation of this animal.

NOW THEREFORE, BE IT RESOLVED that the Hidalgo County Commissioners' Court approves submission of request to relinquish all rights, title and interest in said **K9 "Bombix"** **Asset # 49599**, and all responsibility for its condition and actions, and that therein named **Eduardo Javier Rivera** accepts and assumes full ownership of said dog.

I am aware the canine has aggression training and I am willing to accept full responsibility upon adopting the dog and release the County of Hidalgo, and the Hidalgo County Sheriff's Office from any liability upon taking custody of the dog.

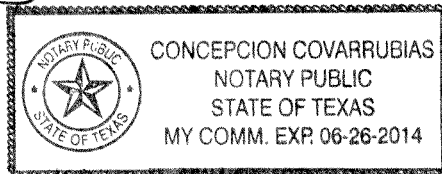



Canine officer Bombix was diagnosed with early kidney failure at our hospital on 2-18-14. The kidneys were normal 7/13 during a routine screening. A second routine screen in 2/14 showed early kidney failure. Bombix was placed on a special kidney diet N/F. Bombix has continued to be fed this food and his kidneys were rechecked on 3-17-14. The kidney enzymes were back to normal. Bombix is responding to the food, but still has early kidney failure. Bombix needs to stay on the N/F food for the rest of his life. With excessive activity or heat exposure he will release moderates amount of protein into the blood which could worsen his kidney failure. I was told by the handler that Bombix is getting tired very quickly during work and is drinking and urinating large amounts. These are all symptoms of the kidney failure. With continued working he will likely progress through kidney failure faster. The best thing for Bombix is to retire so he can have a good quality of life in retirement. Bombix will need to stay on the special food for life and will need periodic blood work to monitor his kidney failure.
