On Dec. 20, 2014, Commissioners' Court approved to amend the interlocal with the City of Edinburg to remove the rate for disposal of tires (\$5.00) and add the cost of \$215.00 per cubic yard container.

Recently, Mr. Ramiro Gomez from the City of Edinburg, has advised us (below e-mail) that the cost provided in December was for a short term and not agreed for the remainder of the interlocal.

Can you please review Amendment No. 1, attached to this email, and modify the language of the amendment. The language of the agreement should not be to delete the rate \$5.00, rather to add the cost of \$215 per cubic yard container for a period of time from December 9, 2013 to December 20, 2013.

Ms. Villareal,

First, I would like to take this opportunity to thank the County of Hidalgo for allowing us the opportunity to continue to serve you as your Solid Waste disposal facility. Second, indeed we are in receipt of the Amendment voted on by Commissioners Court on December 20th of 2013 and transmitted to my office on January 23rd of 2014. I would like to thank you for your interest in securing long-term pricing for the disposal of tires for the County but, after careful review and consideration, unfortunately the City of Edinburg is unable to extend this pricing beyond the time in which it was utilized. This pricing was extended to the County in the spirit of cooperative assistance in removing these tires which were causing a public nuisance and until such time as the County received pricing from their own bid solicitation. The current tire disposal pricing afforded to the County is the City's current contract bid price from its vendor. The City solicits pricing on an as needed basis from prospective vendors and as such, the City maintains no pricing guarantee beyond the current bid contract timeframe and therefore it is not in the City's best interest to maintain or extend pricing that may or may not be afforded to the City during the next bid solicitation. We again would like to thank you for your interest in securing long-term pricing but we must decline in extending such long-term pricing to the County at this time, beyond what we have assisted with. If in the future the County finds itself in need of disposal for this type or any other non-hazardous materials please feel free to contact my office, we would be more than happy to extend to you pricing and assistance in securing disposal for those items.
