**AMENDMENT TO THE  
INTERLOCAL COOPERATION AGREEMENT  
BETWEEN CITY OF PHARR, TEXAS AND  
THE COUNTY OF HIDALGO, TEXAS**

THIS AMENDMENT TO THE INTERLOCAL COOPERATION AGREEMENT BETWEEN CITY OF PHARR, TEXAS AND THE COUNTY OF HIDALGO, TEXAS (“Amendment”), dated June 17, 2014, is made between the CITY OF PHARR, TEXAS, hereinafter referred to as “City”, and the COUNTY OF HIDALGO, TEXAS, hereinafter referred to as “County,” pursuant to the provisions of the Texas Interlocal Cooperation Act as follows:

WHEREAS, on or about January 29, 2013, County entered into an Interlocal Cooperation Agreement (Interlocal) with City for the disbursement of 2011 Operation Stonegarden Grant funds from the U.S. Department of Homeland Security (“DHS”) with CFDA# 97.067 through the State of Texas Governor’s Division of Emergency Management (“GDEM”) and the Texas Department of Public Safety (“TxDPS”), of which certain funds are intended to be subcontracted to various local police departments including City’s police department;

WHEREAS, GDEM and TxDPS have allocated additional funds to County with the instructions to disburse the additional funds to City;

WHEREAS, City and County now desire to amend the Interlocal as hereinafter provided pursuant to GDEM’s and TxDPS’s recent allocation of the additional grant funds;

NOW THEREFORE, for the purposes stated herein, City and County hereby agree to the following amendments to the Interlocal:

1. The previous amount of \$96,417.40 of Grant funds from the County for consideration of City’s performance of services as outlined in **Exhibit “C”** of the Interlocal is increased to \$283,617.62 as delineated in the **Amended City Grant Budget (See attached Exhibit “A” of Amendment)**.
2. The performance period will begin on June 1, 2014 and end on July 18, 2014.
3. Except as modified herein, all terms and conditions of the Interlocal, as amended, remain in full force and effect and City and County ratify and confirm the terms and provisions of the Interlocal as amended.
