### Narrative

On Tuesday February 18, 2013 I Deputy D. Gonzalez 4560 was dispatched to the Hidalgo County Health Department north of Freddy Gonzalez Dr. on the northbound U.S. 281 frontage in reference to a theft.

#### Actions/Observations I,

- arrived at location and made contact with Edinburg P.D. Officer Salazar #73.
- was advised by Officer Salazar that a concerned citizen had called them in reference to the back gate to the county building being open. (agency case no 14-07848)
- observed chain link to be on the ground appearing to be cut.
- observed tire marks and possibly where the trailer scraped the road leaving the compound on to the road and head towards Freddy Gonzalez.
- inspected all vehicles/trailers and found none vandalized.
- searched nearby buildings and did not find any with security cameras.
- advised Sgt. Ramirez of situation who advised he notified CID Supervisor but without any suspect information or leads they would follow up first thing in the morning.
- made contact with director Rigoberto Hinojosa who inspected property and advised there is a trailer missing.
- was provided with information on a black single axel 7x12 Ft. utility trailer that was missing.
- was advised that the trailers license plates were 920-854 and valued at \$1,349.
- he advised that if it still has the county property tag it will be by the tongue of the trailer.
- provided business card with case number.
- made contact with dispatch and entered said trailer.
- was provided with NIC# V826615690
- resumed patrol.
