**Narrative**

On Monday October 28, 2013 at about 0827 hours I, Deputy Jorge Bazan #4415 was dispatched to the North West corner of Highway 107 and Sunflower Road, 923 Sunflower Road Edinburg, TX in reference to a theft.

Reporting party Miguel Angel Cabrera 7/9/76 stated that:

- he is a crew leader for the Hidalgo County Precinct 4
- he arrived to the work site this morning and noticed a black utility trailer to be missing
- the utility trailer had a blue port potty on it
- he does not have the license plate information on the trailer but will provide it at a later time
- he believes the trailer has a GPS tracking system, but can only be accessed by the safety coordinator
- he last saw the trailer on Friday 10/25/13 at around 500 pm

**Deputy's Actions and Observations**

- met with reporting party
- gathered information for report
- observed part of the trailer hitch to be cut and left at location
- advised shift supervisor of this incident
- checked the area for any evidence or witnesses, none were located
- asked Miguel if trailer has anything distinguishing on it, and he stated it has a water tank on it to wash stuff with water
- provided Miguel with a business card and case number
- filed report
- no further actions taken

On Wednesday November 20, 2013 at 1035 hours I, Deputy Albercio Velasquez #3929 and Deputy Russell Suits #4917 were dispatched south of Military road on 10th street in McAllen, Texas in reference to a theft.

Reporting party Jose Segovia (07-29-1963) who said:

- He is the Hidalgo County Precinct 4 Safety Coordinator and had made a report for a stolen trailer.
- This morning he tracked the stolen trailer via GPS leaving from Donna, Texas to the location south of Military highway on south 10th street in McAllen, Texas.
- He waived down a McAllen P.D. unit.
- McAllen P.D. advised to call the Sheriff's Office.

Made contact with Alvaro Saenz (07-12-1985) who said:

- Two weeks ago he was approached by an adult male while working on FM 493
- The male asked if he wanted to buy a trailer from him for \$500.00.
- He paid money and the man left the trailer.
- The man was driving a brown in color early 2000 model Dodge truck.
- He does not know the man.
- He understands \$500.00 was cheap for the trailer and has no problem returning the trailer to the owner.

Deputy Actions/Observations I:

- Observed a small black utility trailer on roadside at a construction site.
- Saw no VIN# or Texas license plates on the trailer.
- Observed the letters "AS" welded on the front end of the trailer.
- Was advised by Jose Segovia the trailer had been painted.
- Was told by Jose Segovia that the GPS was underneath the trailer's wood bed.
- Was also advised by Jose Segovia the 4 holes drilled in the wood bed were what he looked for to identify the trailer as Precinct 4's Property.
- Was told that a blue port a potty toilet and a 45 gallon hand wash station tank were also missing from the trailer.
- Observed the utility trailer had not been entered NCIC/TCIC as stolen due to not having license plates available.
- Obtained a property release form which Jose Segovia signed.
- Observed Investigator J. Espinoza #4405 arrive and take over scene.
- No further action taken resumed patrol.

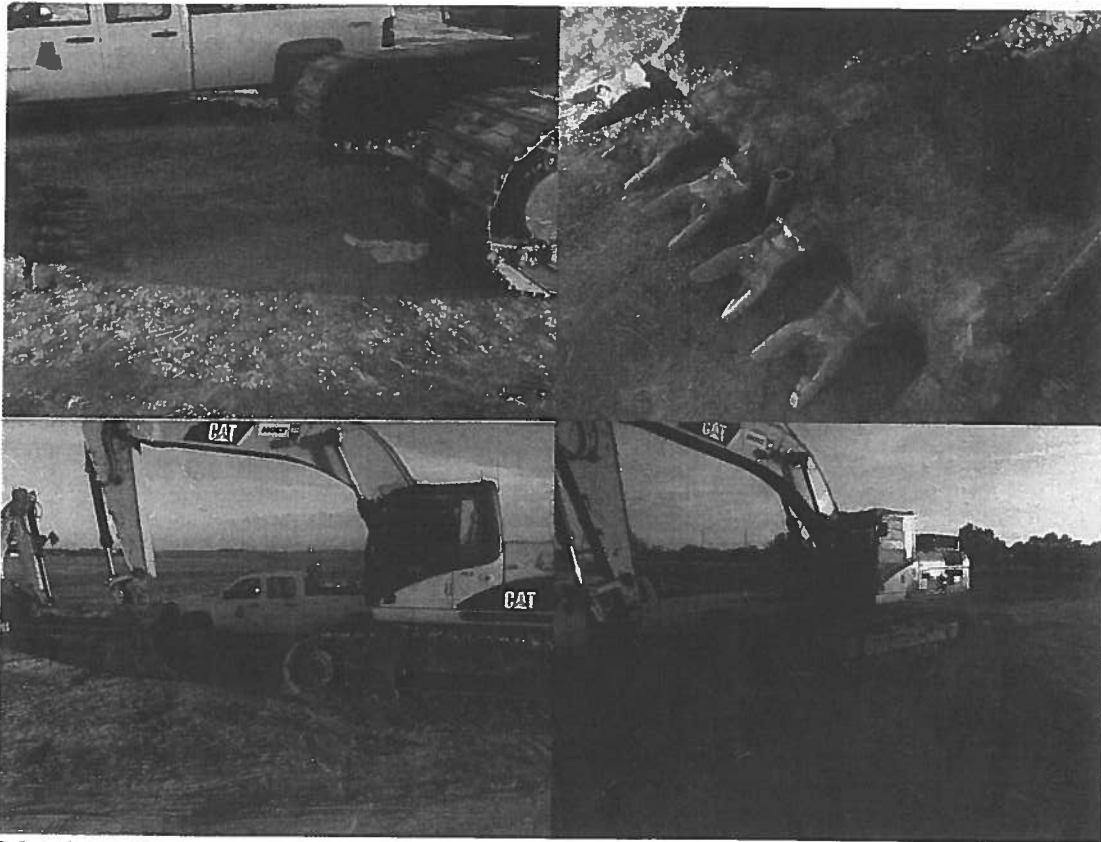

Of Drainage, advised me that Miguel Cabrera had called him on a missing 8 ft. top hat utility trailer, this flatbed trailer had a port-a-potty and water tank for non-portable water. Unit HT110 was placed where they always placed it between the excavators bucket and the tracks, the jack stand of the trailer was cut off, and the trailer was then turned around and taken leaving the stand wedged under the excavator bucket as shown above. H.C.Safety dept & SO was called out. Reports were made awaiting GPS results. Unit HT110 not having any ativity since Oct. 29<sup>th</sup> @ aprox. 7:15am at the shop.
