I have received two separate dialysis treatment agreements (one for Weslaco & one for Edinburg) directed to the Hidalgo County Sheriff's Department. I need to know how you have arrived at the treatment fee of \$425.00 each. Are these based on Medicare/Medicaid Guidelines? In order to have your bills paid, the Hidalgo County Auditor's Office would need to know how this amount was determined. Please advise as soon as possible as we are attempting to present your agreements to the Hidalgo County Commissioner's Court (governing body) for consideration and action. In addition, we will also ask that you provide to us your general liability insurance coverage document as well as worker's compensation. Our goal is to present these contracts on the Commissioner's Court meeting scheduled for 09-09-2014. Therefore, the sooner you provide us with the requested information, the better.
