**FUNDING AGREEMENT
FOR BORDER COLONIA ACCESS PROGRAM
AMENDMENT # 8**

THIS AMENDMENT IS MADE BY AND BETWEEN the State of Texas, acting through the Texas Department of Transportation, hereinafter called the "State" and Hidalgo County acting by and through its duly authorized officials, hereinafter called the "County".

WITNESSETH

WHEREAS, the State and the County executed a contract on the 28th day of August 2008 – amended on the 15th day of January 2009, on the 17th day of March 2010, on the 13th day of August 2010, on the 20th day of June 2011, on the 1st day of November 2011, on the 21st day of March 2012, and on the 23rd day of August 2012 – to effectuate their agreement to establish a transportation program to construct access roads in the County; and,

WHEREAS, it has become necessary to amend the agreement;

NOW THEREFORE, in consideration of the premises and of the mutual covenants and agreements of the parties hereto, the State and the County do agree to amend the agreement as follows:

AGREEMENT

I. Description of Amended items:

Article 3, Schedule, is deleted in its entirety and is replaced with the following:

Upon final execution of this Agreement, the County shall submit a project schedule. This schedule shall include a monthly project development timeline including estimated monthly expenditures. If the County does not complete the Project by August 31, 2015, this agreement will be terminated in accordance with the provisions of Article 9, Termination.

Article 9, item c is deleted in its entirety and is replaced with the following:

Project is not completed by August 31, 2015.

Attachment B, Project Budget, is deleted in its entirety and replaced with Attachment B-1, which is attached to this amendment. This includes the addition of ten Allocation projects (applications for which were previously submitted to the State), and the deletion of five Allocation projects and one Competitive project as indicated below.
