TO AGREEMENT FOR PROFESSIONAL SERVICES

THIS **SUPPLEMENTAL AGREEMENT** is made pursuant to the terms and conditions of Article 5 of the Agreement made by and between **HIDALGO COUNTY**, acting herein by and through the **Commissioner’s Court**, hereinafter called the “**Owner**”, and **RABA KISTNER Consultants, Inc.** Professional Engineers of, **McAllen**, Texas, hereinafter called the “**Engineer**”.

WITNESSETH

WHEREAS, the **Owner** and the **Engineer** executed the **Agreement** on the **12th** day of **August, 2014** concerning engineering for materials testing (the “**Services**”) for the Hidalgo County Precinct No. 2 Owassa Road Paving Improvement Project from City Limits to “I” Road in Pharr , Hidalgo County, Texas (hereinafter referred to as the “**Project**”); and,

WHEREAS, Amendment, establishes that the Estimated Cost is **\$4,197.77**; and establishes the projects to be designed,

WHEREAS, it has become necessary to amend the Agreement to revise the project limits resulting in an increased estimated amount.

A. AGREEMENT

NOW THEREFORE, premises considered, the **Owner** and the **Engineer** agree that said **Agreement** is amended as follows:

- I. The revised limit is from “I” Road West to N. Fir Street.
- II. The Estimated Cost is revised to **\$6,921.64**.
