Michael, I was referring to Section 1-A. The September 1, 2014 would be the starting date of the new fee for this renewal agreement (period). I was asking if we needed to put the year there or is it implied by the September 1st date on the top.

1. Section VI of the Inter-local is amended to read as follows:

- "A. SCHOOL DISTRICT hereby agrees to pay and COUNTY agrees to accept a fee of \$77,172.00 of all current and delinquent base taxes collected from September 1st through August 31st. For subsequent years after reviewing actual collection costs, COUNTY will submit to SCHOOL DISTRICT, prior to May 1st, the fee for the following year. In no event will the cost increase by more than five percent (5%) per year. SCHOOL DISTRICT will have until June 1st to accept the recommended fee.
- B. COUNTY will be paid by deducting the fee at the rate of \$6,431.00 from monthly collections and will submit Monthly Collections Reports"

As we mentioned yesterday, we have already sent these “renewals” to all school districts. Next week, we should be sending all “renewals” to the cities. As for the schools, we have received a few back approved. We were going to follow up with the districts so that we could present all of them at once to Court. By looking at the renewal template attached, I can see that we do not specify a the year (it should be Sept 1 2014 through Aug 31 2015). We are now renewing them in a way where the period is the same as the district’s fiscal year. For McAllen ISD, it would be Jul 1 – Jun 30.

Please review and advise of any changes need to be made. Once we get your proposed revision, we will present all School renewals to Commissioner’s Court at once. The same will be for Cities when we get those. Thanks for your help again.
