Narrative: Ramiro Garza #30

On Friday, April 4, 2014, at 9:38 a.m., I, Officer Ramiro Garza #30, was dispatched to 1001 North Doolittle, in reference to theft.

Upon arrival, I made contact with supervisor, Romeo Zapata (07-10-1952) who advised me that he wants to file a report on a stolen laptop. Romeo informed me that his co-worker, Elizabeth Soto (9-28-1977) advised him about the laptop (Black and Gray, Dell-Latitude E6530). I then made contact with Elizabeth who stated that on the 31st of March around 4:00 p.m. she went to the network room to get two laptops for training. Elizabeth states that while she was gathering the laptops, she noticed one of the laptop boxes was lighter than the others. Elizabeth says that when she opened the box, the laptop and electrical cord were missing.

Elizabeth informed me that when she had first received the laptops, she had 7 of them, which 5 were assigned and 2 unassigned. Elizabeth states that there are no video surveillance around the area and the only people who have access to the network room are the custodians and their technician employee. The value of the stolen laptop is \$942.04 Dollars. Elizabeth provided me with her incident report and she was provided with a case number and advised that a report will be filed.
