Time is running out for the HAZARDS Contractors to request carryover of any remaining BP3 funds.

The FY 14 HAZARDS contracts, which expired on August 31, 2014 included some BP3 funds in the contract, specifically the July 1, 2014-August 31, 2014 allocation outlined in the Special Provisions of your contract.

If your jurisdiction’s July 1-August 31 allocation was not fully expended, you have the option to request the unspent portion (\$1,000 or more) to be added to your “one-time” funded contract through an amendment.

To request this funding, please submit a request to your assigned contract manager (Jonah Wilczynski) by **December 4, 2014** for review and approval.

Please note this amount is also subject to the 10% matching requirement.
