CASE NARRATIVE 8/18/2009 7:11 AM

ON SUNDAY, AUGUST 16, 2009 AT 0845 HOURS I OFFICER J. CAMPOS #10040 WAS DISPATCHED TO 301 E. HACKBERRY AVE. (PALMER PAVILION) IN REFERENCE TO A THEFT.

UPON ARRIVAL, I MADE CONTACT WITH PARK FOREMAN RIVERA, LEONCIO ARMANDO (DOB 4-7-53). MR. RIVERA STATED THAT HE LEFT HIS RESIDENCE LOCATED INSIDE THE ENCLOSED FENCE AT THE PALMER PAVILION, AT 0730 HOURS TO OPEN UP ANOTHER PARK GATE AT A DIFFERENT LOCATION. HE THEN STATED THAT WHEN HE RETURNED TO THE PALMER PAVILION AT 0830 HOURS, HE SAW THAT SOMEONE HAD OPEN THE BACK ENTRANCE OF THE GATE. HE ALSO NOTICED THAT THE 2004 BLACK UTILITY TRAILER THAT IS SUPPOSED TO BE PARKED BEHIND A SHED WAS MISSING. HE THEN STATED THAT THEY HAD ALSO CUT THE CHAIN TO THE REAR ENTRANCE OF THE GATE. MR. RIVERA THEN STATED THAT THE TRAILER WAS WORTH \$2,000.

MR. RIVERA THEN PROVIDED ME WITH THE LICENSE PLATES OF 914 252. I THEN ADVISED DISPATCH TO RUN THE PLATES WHICH CAME BACK TO REGISTERED OWNER HIDALGO COUNTY PCT #2 TO A BLACK 2004 BIG TEX UTILITY TRAILER VIN#16VTX182342E03641. HE ALSO STATED THAT THE TRAILER HAD TWO RAMPS ON THE BACK OF THE TRAILER AND THE UNIT #64 PAINTED IN WHITE ON THE SIDES OF THE TRAILER. I ALSO ADVISED DISPATCH TO ENTER THE TRAILER AS STOLEN INTO NCIC/TCIC. DISPATCH THEN ADVISED ME THAT THE TRAILER HAD BEEN ENTER AS STOLEN INTO NCIC/TCIC BY ECS Y. HERNANDEZ #8533 AT 1244 HOURS. MR. RIVERA THEN STATED THAT HE WISHED TO FILE THE PROPER CHARGES OF THEFT ON THE UNKNOWN SUSPECT(S).

R/P STATED THAT UNKNOWN SUSPECT(S) STOLE A BLACK 18 FT. UTILITY TRAILER.
