The quick answer on the timing issue is that if the agreement is not approved this year, it would likely push funding back a year (meaning two payments would not be made in 2015 because only one payment is budgeted for the year.) I know that is not what you were hoping to hear, and I suspect the county would not mind hearing arguments to the contrary, but that appears to be the concern if an agreement is not approved this year.
