I just got off the phone with Mr. Sadler and he has declined the idea of having only one agreement with multiple users. He will submit an agreement per department as requested - so far he's only received requests from Planning and Pct. 2 ROW.

On the question whether they will allow multiple users per agreement, he said they will probably not have a final decision reached until early part of next week since Mr. Sweeten is out of town. He is concerned with assuring that we provide a level of control of who has access to the login credentials.

Since he's requiring individual signed agreements, I suggest that all department's requiring access to Carson Maps call or email their requests (with the amount of users required) immediately so it can be responded to as soon as they make their decision. This will help if we are to try to take care of all agreements under the current agenda item scheduled for next CC meeting (with modifications taken into account). Copies of everyone's agreement will be needed at that time so it can added to this agenda (AI-48260).

Please be aware that our Planning and Engineering Department consists of over 25 staff members that utilize the software on a daily basis for development permit reviews and County engineering projects. We need all 8 users because with 1 user only 1 staff member can use it at a time.

I have already conveyed this concern of the need for 8 users to Mr. Sadler of the Carsonmap Company and am awaiting his response. You may want to ask the other County departments about their minimum usage requirements so

that a lease agreement can be prepared for them separately.

Please be aware that all of us are currently locked out of the login for carsonmap.com due to violations of the attached agreement. Apparently private companies, including one particular real estate office, have been using the login and password. This has taken away potential customers from the carsonmap company and has caused us to be locked out.

Mr. Sadler as owner of the company has asked us to once again execute the attached lease agreement and limit the use to Planning Department employees only. This does not mean that you are prohibited from doing business with carsonmap. I suggest that if you are wanting to gain access again that you contact Mr. Rob Sadler at 956-797-1514 or email rob@carsonmap.com to learn how you can execute an agreement with the company.

We have instructed our staff to not disclose the future login and password to any non-planning department employees once it is available to us. Any non-compliance coming from our staff will come with consequences. You may want to issue a similar warning to your co-workers and/or staff.
