**AMENDMENT TO THE
MUSEUM FUNDING AGREEMENT BETWEEN
THE COUNTY OF HIDALGO, TEXAS AND THE MUSEUM OF SOUTH TEXAS
HISTORY**

THIS AMENDMENT TO THE MUSEUM FUNDING AGREEMENT BETWEEN THE COUNTY OF HIDALGO, TEXAS AND THE MUSEUM OF SOUTH TEXAS HISTORY (Agreement) dated January 20, 2015, by and between the County of Hidalgo, Texas, (County) and the Museum of South Texas History, (Museum), is entered between the parties this ___ day of February, 2015.

WHEREAS, Museum and County entered into an Agreement dated January 20, 2015, in which Museum was to provide the services of a County historical museum; and County agreed to assist Museum by providing funding for use in operating its facilities during the calendar year 2015;

WHEREAS, County agreed to pay the sum of Two Hundred Seventy Thousand and 00/100 Dollars (\$270,000.00), payable in twelve (12) equal monthly installments, beginning January, 2015 and ending December, 2015, as consideration for the services provided by Museum;

WHEREAS, County and Museum now desire to amend the Agreement as hereinafter provided;

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Museum hereby agree to the following amendments to the Agreement:

1. County agrees to pay an additional sum of Ninety Thousand and 00/100 Dollars (\$90,000.00), for services provided for and on behalf of the County under the Agreement, for a total sum of Three Hundred Sixty Thousand and 00/100 Dollars (\$360,000.00);
2. This total sum (\$360,000.00), less the two installments disbursed prior to this amendment for the months of January and February 2015 (\$45,000.00), shall be payable in ten (10) equal monthly installments of Thirty One Thousand Five Hundred and 00/100 Dollars (\$31,500.00) through the remaining term of the Agreement ending December 31, 2015;
3. Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect and the County and the Museum ratify and confirm the terms and provisions of the Agreement as amended.

WITNESS THE HANDS OF THE PARTIES effective as of the date of the last party to sign this Agreement.
