**FIRST AMENDMENT TO CONTRACT #C-12-008-03-20
PRINTED ITEMS AND RELATED SUPPLIES**

This **AMENDMENT** to the **CONTRACT** is made this **3rd day of March of 2015** by and between **HIDALGO COUNTY, TEXAS** (the “**COUNTY**”) and **Gateway Printing & Office Supply, Inc.** (the “**COMPANY**”).

WHEREAS, County and Company entered into a Contract on **March 20, 2012** (the “**CONTRACT**”) in which the Company agrees to provide printed items and related supplies as described in the Contract;

WHEREAS, the County’s awarded vendor who provided services refuses to supply required insurances to County and County requires services from Company from another vendor;

WHEREAS, the Company agrees to honor and hold the prices as detailed under “Exhibit B1-Modified Bid Page-Additional Items” of contract; and

WHEREAS, the parties have now determined to amend the Contract to include certain items from County’s other awarded vendor.

NOW THEREFORE, for and in consideration of the additional items by Company specified in Exhibit B1-Modified Bid Page-Additional Items, County and Company hereby mutually agree to the following Amendment to the Contract:

1. Exhibit “B”-Bid Page the Contract is hereby deleted and the amended Exhibit B1-Modified Bid Page-Additional Items attached hereof as Exhibit is substituted in lieu thereof;
2. Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect. County and Company ratify and confirm the terms and provisions of the Contract as amended.
