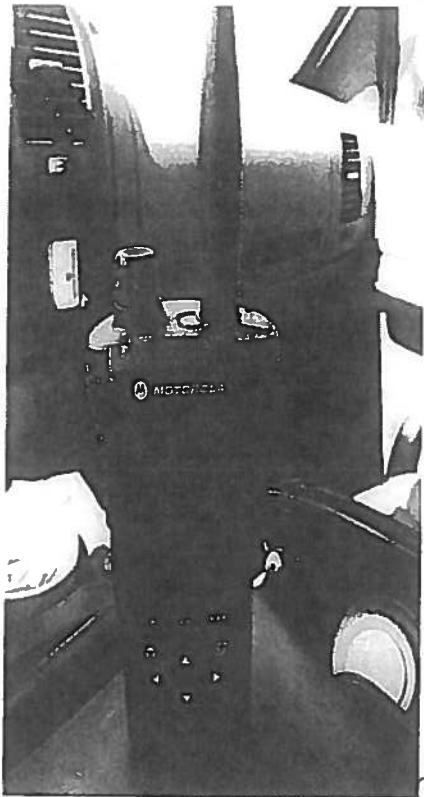
Narrative: Ricardo Trevino #68
