AAMECC is a Texas Department of State Health Services (DSHS) licensed asbestos consulting agency no. 10-0495. The proposed scope of work, the proposed budget, and our anticipated work schedule is outlined below using the approved TIPS Contract No: 1042513 for professional services.

SCOPE OF WORK

AAMECC's project approach consists of three (3) tasks: **first**, prepare specifications for the abatement project; **second**, provide project monitoring services; and **third**, provide air monitoring services for the abatement project.

Task 1.0 Specifications

AAMECC shall prepare the abatement specifications. These specifications shall itemize areas to be abated for long term liability control and will be prepared by a DSHS licensed asbestos consultant. DSHS Notifications will be prepared and submitted for each location.

Task 2.0 Project Air Monitoring

AAMECC will carry out the necessary area and clearance air sampling to establish a baseline in support of the environmental compliance requirements of the project using Phase Contrast Microscopy (PCM).

Task 3.0 Air Monitoring

AAMECC will carry out the necessary area air sampling to establish a baseline in support of the environmental compliance requirements of the project using Phase Contrast Microscopy (PCM). Additional, daily air monitoring will be conducted during the project along with final clearance sampling.
