In consideration of \$8855.00, Claimant hereby releases and forever discharges Defendants from any and all past, present, or future claims for any and all property related damages sustained to his/her vehicle that Claimant has or claims to have, arising out of the incident which occurred on or about 11/24/2014 in HIDALGO County, Texas, (hereinafter referred to as "the Occurrence").

Claimant understands and agrees that this property damage settlement is not to be considered an admission by any party hereto of any liability or wrongdoing, but rather the compromise of disputed claim. Defendants expressly deny any liability or wrongdoing.

Claimant understands and agrees that this settlement is a full release and discharge of claims and/or causes for property damages related to his/her vehicle **2008 FORD EXPEDITION VIN# 1FMFU15548LA07788** including but not limited to rental car expenses, storage expenses, wrecker expenses, diminution in value, loss of use, attorneys' fees, exemplary damages, prejudgment and post-judgment interest, court costs or other expenses of litigation, and claims for any other element of loss or damage to this/her vehicle recoverable under law.

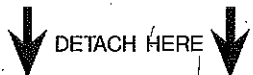
