Thank you for your inquiry. Our office has reviewed the correspondence from Reliant regarding the Bundled Contract Price Adjustment-County of Hidalgo, wherein the Court has been put on notice that AEP has been authorized to recover costs, via adjustments in rates, increases or decreases, of transmission and distribution charges from retail electric providers (i.e. Reliant).

In reviewing GLO Contract No. 08-5120-000-3301 First Amendment To Electric Sales / Appendix B Contract Charge, it is noted that in addition to the Contract Charge bundle components include other charges expressly authorized by the agreement.

These include Ancillary Charges assessed by the ERCOT for services necessary to ensure a reliable operation of the transmission system, as well as Transmission and Distribution Charges, which includes cost recovery charges and fees authorized by the Transmission Distribution Service Provider's tariff billed to Reliant.

As such, it is permissible for Reliant to begin billing at a revised contract price which includes adjustments for AEP's rate changes related to transmission and distribution cost recovery.

It is my understanding that the Commissioner's Court has retained outside counsel to review the existing energy contract. Therefore, please let us know if your office has been given any direction on the contract which may affect our review.
