Indirect funding resources (also referred to as leveraged funds) include the TDHCA Colonia Fund, the Economically Distressed Areas Program (EDAP), and Texas Parks & Wildlife funding. Federal funding is leveraged through the Economic Development Administration (EDA), the Environmental Protection Agency (EPA), USDA Rural Development Agency, loans and grants offered through the North American Development Bank (NAD Bank), and public housing authorities' funding, meals for elderly, and youth programs. Local funding resources are mainly through Municipalities, Hidalgo County Road & Bridge funds.
