FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT

This AMENDMENT to the PROFESSIONAL SERVICE AGREEMENT by and between Hidalgo County, Texas acting by and through the Hidalgo County Urban County Program ("Party") and Quintanilla, Headley and Associates, Inc. ("Engineer") is entered into between the parties effective this 31 day of March, 2015.

WHEREAS, Party and Engineer entered into a Professional Services Agreement dated May 22, 2012 in which Engineer agreed to provide certain engineering services for the GLO Flood and Drainage Improvements Project known as the "Delta Area Connector/ East Lateral" Colonia Infrastructure Improvements II Account(s) 6540-62-0309-5100-6200 (the "Agreement");

WHEREAS, the Agreement now requires amendment in order to add additional services of revising main storm sewer as more particularly described in Exhibit A-1 attached hereto surveys and to revise the fee to the Engineer for the additional work; and

WHEREAS, the parties desire to amend the Agreement as herein provided;

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Party and Engineer agree to the following amendments to the Agreement:

1. The Agreement is amended by the additional services of the Engineer more particularly described in Exhibit A-1 attached hereto.
2. The first sentence of Section 6.1 of the Agreement is deleted in its entirety and the following is substituted in lieu thereof:

The Engineer shall be paid a total fixed amount of \$170,980.00 for services rendered under this contract.

3. Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect and Party and Engineer ratify and confirm the terms and provisions of the Agreement, as amended.

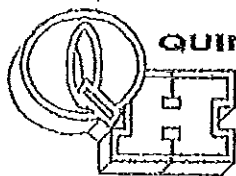

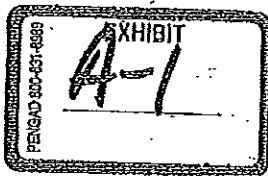

Good afternoon. Urban County Program is requesting your legal counsel concerning Amendment No. 1 to a professional service agreement for the Texas General Land Office, GLO Contract No. 12-406-000-6453/DRS210068 project known as the "Delta Area Connector/ East Lateral Project Colonia Infrastructure - Tijerina Estates & Sunrise Subdivision.
