"Effective immediately, due to overwhelming demand, there will be a fleet constraint on MY 2015 Tahoe's for an undetermined period of time."

Note:

This includes: Tahoe PPV's, Tahoe SSV's and all fleet Tahoe orders.

The above notice was received from GM Fleet in Detroit on Monday afternoon.

As a result, any MY 2015 Tahoe orders received after Friday, March 20th, from South Central Region Chevrolet Dealers, will be handled on a "will try" basis.

The South Central Region is in an over-sold position for MY 2015 Tahoe orders vs allocation, so it appears that orders received prior to March 20th may be in peril and may be cancelled.

As I receive additional information from GM Fleet in Detroit I will cascade it to your attention.
