I spoke with Charlie this morning regarding the cost for repairs at the San Juan Park (Report# 15-01-25-0900). You send me the cost estimate to replace the plants, but not for the labor. I need the cost estimate for the labor part...since we are going to fix in house, I need something from your office with the amount so that we can proceed with the claim. I want to say Charlie mentioned that it would take 2 employees approximately 8 hours of labor to accomplish the repairs. Can you send me something to reflect that.
