The 2013 Operation Stonegarden performance grant period will end May 31, 2015. Total funding awarded to Hidalgo County under Operation Stonegarden 2013 was \$3,321,163.51. These funds were shared with sixteen (16) local law enforcement agencies which were invited to participate in 2013 Operation Stonegarden.

The Hidalgo County Constable Precinct 1 was awarded \$72,527.86; however, they have nearly exhausted their funds and actually went over on overtime and fringes.
