Sir, I was contacted by Joshua Alvarado of Healthweb CE and there is on last correction that needs to be made to the MOU. Line 25 is highlighted and needs to be removed and approved by commissioners court before we are issued the final approval. It is vital that this be presented the next commissioners court for the course to be approved. This is the last correction that is needed. If presented to commissioners court, scheduled April 15, 2015, the course will only be pushed back two days and the class schedule will be adjusted accordingly. I have attached the deficiency letter from the State, scanned copy of the last approved MOU and the MOU with the highlighted section that has to be removed. The removal of this section does not effect the Sheriff's Office section of the MOU in anyway. It only effects the presentation of advanced skills during the course of instruction.
