The City of Granjeno loaned Precinct 1 \$500,000.00 through an Interlocal Agreement for the completion of an already environmental cleared Street Improvements Project. Hidalgo County Precinct No. 1 will repay the loan within a period of two years (\$250,000.00 a year) from its Hidalgo County Urban County Program funds beginning Fiscal Years 29 & 30 (2016 & 2017).
