On Tuesday, March 18, 2015 at 9:58 AM, bids were opened on the above referenced project by Urban County Department, Hidalgo County. A total of two (2) bids were received. The bid tabulation for the project with individual bid items is attached.

The lowest bid received was from G&G Contractors in the amount of \$349,065.68. The available funds from this project as of to-date are \$237,372.83.

In lieu of the shortfall in funding, S&B recommends City of La Joya to fund the \$111,692.85 shortfall identified by Ms. Guadalupe Garcia to complete the project.

S&B Infrastructure LTD hereby makes a recommendation to award the contract to G&G Contractor's contingent upon approval and release of funds from City of La Joya and Urban County Program, Hidalgo County.

CONTRACT**

This Agreement entered into this 5th day of May, 2015 by and between Hidalgo County acting by and through Hidalgo County Urban County Program, hereinafter called the "OWNER", acting herein through its County Judge and RG ENTERPRISES dba G & G CONTRACTORS (a corporation) of Edinburg, State of Texas, hereinafter called "CONTRACTOR".

WITNESSETH

That for and in consideration of the payments and agreements hereinafter mentioned, to be made and performed by the OWNER, the CONTRACTOR hereby agrees with the OWNER to commence and complete the construction described as follows:

PROJECT NAME: La Joya-Parks, Recreational Facility Improvements
PROJECT No.: 5010-40-0306-5000-4000-UCP-GVG
PROJECT DESCRIPTION: Military Park

Heinafter called the project, for the sum of (\$349,065.68) – Three Hundred Forty-Nine Thousand, Sixty Five Dollars and sixty-eight cents and all extra work in connection therewith, under the terms as stated in the General and Special Conditions of the Contract; and at his (its or their) own proper cost and expense to furnish all the materials, supplies, machinery, equipment, tools, superintendence, labor, insurance, and other accessories and services necessary to complete the said project in accordance with the conditions and prices stated in the Proposal, the General Conditions, Supplemental General Conditions and Special Conditions of the contract, the plans, which include all maps, plats, blue prints, and other drawings and printed or written explanatory matter thereof, the specifications and contract documents therefore as prepared by S & B INFRASTRUCTURE, LTD. and as enumerated in Paragraph 1 of the Supplemental General Conditions, all of which are made a part hereof and collectively evidence and constitute the contract.

The CONTRACTOR hereby agrees to commence work under this contract on or after a date to be specified in a written "Notice to Proceed" of the OWNER and to fully complete the project within 90 consecutive calendar days thereafter. The CONTRACTOR further agrees to pay, as liquidated damages, the sum of (\$200.00) Two Hundred Dollars and Zero Cents for each consecutive calendar day thereafter as hereinafter provided in Paragraph 19 of the General Conditions.

The OWNER agrees to pay the CONTRACTOR in current funds for the performance of the contract, subject to additions and deductions, as provided in the General Conditions of the contract, and to make payments on account thereof as provided in Paragraph 25, "Payments to Contractor", of the General Conditions.
